Attached hereto are several documents regarding the above referenced property. Previously, you have been provided with notices from the City of Helena-West Helena Code Enforcement Officer and you have not responded. You property remains in disrepair, unsightly, and has been determined to be a nuisance by the Code Enforcement Officers. This notice is the City's last attempt to bring you into compliance and for you to correct all issues on the property.

In addition to the notices that were previously forwarded to you, I have attached an ordinance authorizing the condemnation of your property. This is a very serious matter and should not be ignored by you. Please contact the Code Enforcement Officer immediately if you desire to resolve this matter prior to the City moving forward with additional measures. The Ordinance that is included will be on the City Council's agenda on the first Tuesday in December; however, you must respond to Code Enforcement by October 31, 2020. 
